## ORDER:-

All the District Educational Officers and Additional Project Coordinators, Samagra Shiksha in the state are informed that the United Private Educational Institutions Federation and others have challenged G.O.Ms.No. 6 School Education (Pogram.II) Department dt. 01/02/2024 and consequential Notification issued by the State Project Director vide Rc. No. SS-18021/2/2024/RTE SSA, dated 09/02/2024 for providing 25% admissions in IB/ICSE/CBSE/State syllabus schools for Class-I in the State for the year 2024-25 under 12(1) ( C) of RTE Act, and also apprised to the Hon'ble Judge for not paying the tuition fee for the last two years 2022-23 and 2023-24.

In this context, it is further informed to all the District Educational Officers and Additional Project Coordinators, Samagra Shiksha in the state it is clearly mentioned in G.O.Ms.No. 24, School Education (Prog.II) Department, dated: 26/02/2023 to pay the tuition fee to the Private Un-aided schools based on the geographical condition who provided the 25% admissions in Class-I to the children of Disadvantaged Groups and Weaker Sections under 12(1) ( C) of RTE Act by the mother's who got the Ammavodi amount from the Government.

However, it has come to the notice of the undersigned, that no District Educational Officer/Addl. Project Coordinators have not been taken any initiation regarding payment of Tuition Fee to the concerned Private Schools by the Mother's even after the received Ammavodi amount.

Therefore, all the District Educational Officers and Additional Project Coordinators, Samagra Shiksha in the state are hereby instructed to take necessary action and issue the instructions strongly to the concerned MEOs in your jurisdiction and see that to pay the tuition fee for the two academic years by the mother's concerned to the Private Unaided schools within 3 days who received Ammavodi amount as per Rules in force. Submit the compliance report to this office for onward submission to the Hon'ble High Court of AP.

This should be treated as most URGENT.
